

# DATA PRIVACY STATEMENT FOR WEB PAGE VISITORS

This data protection notice is intended to provide an overview as to what personal data is processed when you visit the website of FRÜH & PARTNERS ASSET MANAGEMENT LTD. (hereinafter referred to as "FP") at <a href="https://www.fpartner.li">www.fpartner.li</a>.

## 1. Description and scope of the data processing and your rights

The processing of personal data of visitors to our website is limited to data that is required to provide a functional website as well as our content and services. Personal data of visitors to our website is only processed for the purposes agreed-upon with you or if another legal basis (as defined by the GDPR) exists. We only collect personal data that is required for the purpose of carrying out and fulfilling our duties and services or data that was provided to us on a voluntary basis.

### 2. Provision of the website

When you visit our website, our web server collects automated server log files, i.e., data and information from your computer. The following data is collected in the process:

- type and version of the browser;
- operating system used;
- referrer URL (the previously visited page);
- IP address/host name of the accessing computer;
- date and time of the server inquiry;
- name of the file retrieved;
- transmitted data volume;
- notice of successful retrieval.

We are not able to associate this data with individuals. This data is not combined with data from other sources. Subject to potential statutory retention periods, the IP addresses of users are deleted after use has been completed. Data that cannot be associated with a particular user is only stored temporarily and statistically evaluated to ensure system security and user data security (e.g., to detect potential incorrect links and program errors as well as attacks on the system).

#### 3. What are cookies?

Cookies are small files that are automatically created on your browser and stored on your device (laptop, tablet, smart phone etc.) when you visit our website.

#### 4. What do we use cookies for?

We use cookies to make our website more user-friendly. Cookies allow us to recognize your device the next time you visit our website and thereby enhance our website and optimize it to your needs. The majority of cookies we use are so-called "session cookies." These cookies are automatically deleted at the end of your visit or after expiration of one day. Other cookies remain stored on your terminal until you delete them.

# 5. Consent and withdrawal of consent to cookie settings

When you visit our website for the first time, you will be asked to consent to and allow the cookies. You will have the option of providing consent that allows only essential cookies or consenting to all cookies. If you would like to learn more about which cookies are used in detail when you visit our website, please click on the button «Cookie details or individual data privacy settings», which lists and describes all the cookies we use. You will also find information about the retention period of the cookies that are used. At this point, you will also have the option of consenting to or rejecting the individual cookies.

You may withdraw your consent to the cookie settings at any time by clicking on the following «Optin/Opt-out» button:

Opt-in / Opt-out

You can also withdraw your consent to the cooking settings at any time by clearing your browser history. When you return to our website, you will then be prompted again to consent to the cookie settings.

You can configure your browser to inform you when cookies are used so that you can decide on a case-by-case basis whether to accept or reject a cookie. Alternatively, your browser can be configured to automatically accept cookies under certain conditions or to always reject them, or to automatically delete cookies when closing your browser. Disabling cookies may limit the functions of this website.

The legal basis for the data processed by essential cookies is Article 6(1)(f) GDPR («legitimate interest»), and the legal basis for the data processed by cookies placed by other media is Article 6(1)(a) GDPR («consent»).

## Third-party cookies

A cookie may be placed on your computer by third parties if you follow a link that causes you to leave our web server. We work with the following service providers that may use their own cookies or third-party cookies:

# 6. Google Maps

We use the Google Maps service, which is operated by Google LLC, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA. Processed data may include, in particular, users' IP addresses and location information. This data, however, will not be collected without the user's consent (the consent process is generally part of your settings on your mobile devices). The data may be processed in the USA.

# 7. Cloudflare Content Delivery Network

We use the Content Delivery Network (CDN), operated by Cloudflare, Inc., 101 Townsend St, San Francisco, CA 94107, USA.

A content delivery network is a service that allows faster delivery of the contents of our website, especially large media files such as graphics or scripts, via regionally distributed servers connected via the Internet.

The users' data is processed solely for the purposes outlined above as well as to maintain the security

and functions of the content delivery network.

8. WordPress

The WPML cookie stores the language selected and is placed on your computer by the owner of the

website. This cookie is enabled for anyone who visits our website when the visitor uses the Browser

language redirect function or when he or she has consented to use of this cookie when visiting our

website for the first time.
